I saw him a couple of times here in SD and he said his medical file was so thick as he had been referred around to many doctors about his condition. The story is one morning he started coughing up blood and died in the living room of his house at the young age of 28.

Every time I would mention Jim's name, my mom would swoon, "he is a handsome young man". He was and most of all he was a good friend to so many of us who knew him. May he rest in peace in God's arms.
